# **Matters Arising:**

112-1115 **Neighbourhood Plan Operational Group** – N Smith and J Bumpus attended. Letter to residents discussed.

113-1115 **Clearing Barsham Village Sign Area** - will be completed when weather permits.

Barsham War Memorial site has been weeded, the grass cut and the Memorial seat in memory of Denis Sporle cleaned.

114-1115 **Bus Service 80 Route Change** – Reply received from Anglian Bus. The decision to change the route was made by their route planners and operators in order to provide a better service for customers, decisions will be made based on many varying factors and influences. Many customers have contacted them regarding the changes, should enough do so the route may be reviewed. From 2<sup>th</sup> November route 80 has changed to the Norfolk side between Beccles and Bungay.

122-1115 Parish Precept 2016/2017 – The Clerk presented the estimated budget to the Councillors and went through the costings. The bank balance has been building up to enable the PC to cover the cost of £2415.52 which would be owing to WDC if two separate contested elections took place, in addition the Clerk has not taken any salary for three years totalling approx £1900.00. Both parishes did not hold contested elections in May 2015 as not enough residents were prepared to stand. The two uncontested elections cost £252.84. The Clerk recommended that the precept should be reduced. After discussion Mrs P Midwinter proposed and Mrs J Howell seconded the proposal that the Precept for 2016/2017 would be reduced by £600.00 to £1250.00 all agreed.

## **Any Other Business:**

124-1115 **Mud on B1062 Barsham** – After the October PC meeting several complaints regarding the volume of mud being left on the Beccles side of the old dual carriageway were received. Suggestions were that it was caused by heavy lorries and farm vehicles that were constantly on and off the field being used for bulk storage. SCC Highways have been informed.

125-1115 **Stolen Walnuts** – Email received from the owner of The Old Rectory, Barsham.

Two walnut trees were planted in the private park at the front of the house, every year since the trees have fruited the walnuts have been stolen. As a consequence of these persistent acts of dishonesty the two gates into the park will be padlocked to prevent any access.

126-1115 **Village Hall Entrance of the B1062** – The Chairman reported the problem of vehicles parking in the lay-by in front of the Village Hall entrance and therefore blocking entry or exit. Would some form of hatching on the road at the entrance prevent this?
