Matters arising:

33-0416 External Audit for Smaller Authorities – After the March meeting the latest communication from Smaller Authorities Audit Appointments was received regarding changes to the auditing of the accounts, it was clear from this information that the PC could not continue with its present decision to opt out. Mr J Bumpus proposed and Mr P Holmes seconded the motion to opt in and to retract the previous decision to opt out. All agreed.

34-0416 **Barsham and Shipmeadow Community** – PC representatives mentioned the idea of having film shows in the Village Hall to help raise funds for the inside toilets project to the Village Hall Committee. The VH Secretary approached "Flicks in the Sticks", after research it was clear the cost would not make it a viable fund raiser.

35-0416 **B1062 Speed Limit Barsham, Shipmeadow and Mettingham** - SCC Mr D Ritchie gave an update of the current situation. Mark Kerridge SCC Highways is gathering evidence on his behalf for a 50mph speed limit and it will be presented to the Speed Panel on Monday 18th April 2016. Previously the B1062 did not fit the criteria for a reduction to 50mph. The Police now support a reduction to the speed limit due to the increased volume of traffic in and out of Masiebrook Farm. Mr Ritchie explained this may be a border line case with a 50/50 chance of success, he has held back some of his highway budget to help with the cost if successful. The Councillors thanked Mr Ritchie.

41-0416 **Gull Lane Byway** – It was suggest a letter should be sent to Annette Robinson SCC East Area Rights of Way Manager in regard to downgrading the Gull. Clerk to contact.

42-0416 **Barsham Village Sun Sign** – A professional job of repainting the sign will need to be achieved over the summer months. Various painters' names were passed to the Clerk to obtain estimates.

43-0416 **Barsham War Memorial** – The Village Hall Committee have informed the PC of an account held at Barclays Bank in the name of Barsham Aviation Memorial Fund. This apparently has a balance which had been raised to maintain the memorial. The VHC is looking for clarification regarding signatories for the account. The memorial paving slabs are uneven and in need of relaying/replacing on a membrane base with the gaps pointed to prevent weeds growing through.

44-0416 **Roadworks B1062 Barsham** – Several complaints regarding the vast amount of spoil that has been placed on the footpath to enable the recent repairs to be carried out. This has not been removed; residents cannot walk safely along the footpath to Beccles. SCC Highways have been contacted.
