## **Matters Arising:**

15-0216 **Bus Service 80 Route Change** – After being welcomed Mr Peter Lee Interim Business Manager of Anglianbus spoke at length of the challenging position the company find themselves in. They are hoping to stabilise and move forward in the future. He realises that many "Out of Service" buses travel along the B1062 to the depot at Ellough. There is a need to utilise vehicles to their maximum. It will probably be the summer before they look again at the routes, local input would be welcomed. Councillors spoke of their concerns. The PC will keep in touch Mr Lee via email.

16-0216 **Village Hall Entrance off the B1062** – The Village Hall Committee are in approval for the PC to approach Suffolk Highways to suggest some form of hatching in the lay-by to deter vehicles parking and blocking the entrance to the village hall entrance. Clerk to contact Highways.

17-0216 External Audit for Smaller Authorities with Annual Turnover of below £25,000 – More information has become available, all Councillors received copies. The decision to opt out or not must be made at the March meeting before the 31<sup>st</sup> March deadline.

18-0216 **Shaping the development of the Railway, East Coast Line Group** – Mrs Midwinter reported back after attending the meeting held on 14<sup>th</sup> January 2016. The Group are very positive with lots of different ideas to move forward. The Station will have toilets, a waiting room and a Cafe will be open soon, partly run by volunteers with some paid help.

19-0216 **The Gull By-Way, Shipmeadow** – The Chairman attended a meeting at Boundary Farm, Shipmeadow with Annette Robinson SCC East Area Rights of Way Manager. A Temporary Closure of Byway 5 Ilketshall St John, Byway 16 Shipmeadow, Byway 17 Shipmeadow and Footpath 18 Shipmeadow will be closed to motor vehicles and horse drawn carriages due to the surface becoming severely damaged by vehicle use. The closure is to prevent further damage and to allow for recovery. Co-ordinated works may also take place during this period. It is intended that he closure will operate until 20<sup>th</sup> July 2016. Further problems with 4 x 4's have been reported to the Police by residents.
