50-0518 Chairmans Report:

B1062 Beccles to Bungay Speed Limit – On the 30th June 2017 the 50 mph speed limit came into operation. The campaign to achieve the reduction from 60 mph has taken two decades. It took a while to settle in. Although in general people were driving within the limit, there were many speeding well over the limit. Police made regular speed checks which did make a difference. Random speed checks are continuing. On the whole it has made a considerable safety difference to the residents of the three villages.

Barsham Red Telephone Box – After advertising for ideas from residents for the use of the box, none were received. Councillor Mrs P Midwinter suggested turning the box into an information point. Glazing is the main issue, parts and kits can be purchased on line. Estimates are being obtained.

Barsham War Memorial – Groundwork maintenance is necessary. Estimates are being obtained.

Wind Turbine. Laurels Farm - S R Power Ltd had the Discharge of Conditions for the turbine site approved by WDC Planning, after allowing the developer to make changes to the conditions agreed in the original plan. The PC letters were not addressed satisfactory in the officers discharge report. At the time of this meeting a local resident and the airstrip owner in Shipmeadow have started proceedings for a judicial review against WDC.
