## **Matters Arising:**

01-0118 **Red Telephone Box** – Clerk confirmed estimates are being sourced.

02-0118 Barsham War Memorial Area – Clerk confirmed estimates are being sourced.

03-0118 **Blocked Drains, Clarkes Lane B1062 Junction** – Response received from Suffolk Highways. They have assessed the severity of the issue and will not be taking any remedial action at this stage. They will monitor this location as part of their routine inspections and if the matter gets worse will look to prioritise suitable remedial works.

04-0118 Missing White Lines/Road Studs B1062 Shipmeadow – Response received from SH. "The lines have not been replaced in line with our current policy of not replacing centre safety lines on roads other than A class roads." Clerk reported an email had been received from a member of the public who is concerned that it is dangerous to leave them as they are, as at night or in fog cars are prone to wander in advance of the bends. Councillors are not satisfied with SH response and will contact Suffolk County Councillor Mr D Ritchie.

05-0118 **Appointment of Data Protection Officer** – Further information received from SALC advising some councils have received "alternative" information which suggests the Clerk will be able to act as the DPO. This is misleading and incorrect.

## **Any Other Business:**

10-0118 **Callendars Houses Barsham Lane and beyond** – A Barsham resident has raised a question concerning this area, whether WDC (who light and collect bins from it) might consider surfacing it. The problem of who is responsible for repair of the lane has been looked into by the PC several times over the years. SCC advised in 2006 (minute ref 02-0106) records had been checked and this road is not a highway maintainable at public expense, WDC records department also confirmed that they do not maintain it.

11-0118 **Footpath from Barsham Church to Village Hall** – Letter received from a Barsham resident. The field gate opposite the church lych-gate has been lock for some time and recently a new field fence has been erected with no access gate across the village hall field. This has been a footpath for many years and in the residents opinion it is important to keep it open as it connects the church to the village hall and other footpaths.

Clerk to contact resident and owner of land.

12-0118 **Flooding and Subsidence Low Road, Shipmeadow** – The PC have been made aware of this problem from a Low Road resident. There seems to be a need for ditches and gullies to be cleared of obstructions in this area. The road is beginning to subside due to flooding. Clerk informed SH. Ref number 00191672.
